FINDING MY OFFICE

My physical office is in the historic Fairlington neighborhood on the boarder of Arlington and Alexandria Virginia. It is approximately 8 miles from the District. It is easily accessible from 395. It is approximately 1 mile up 31st St from the popular Village at Shirlington in Arlington. Parking around the office is plentiful and free.

My office is in a small office park with two story red brick buildings. The firm is in the building with a large sign on the outside that reads, "The Huntington Learning Center." My office is on the second floor on the right as you come up the steps.

From 395 via Shirlington

Exit 7 Right toward Shirlington

Take the Shirlington Exit

Turn left onto Quincy Street

* Quincy turns into 31st Street, which is a two-lane street that parallels 395 on your left.

* You should pass a bus station on your left

* You will go up a steep hill

Go through stop sign after you crest the top of the hill (31st and Abingdon)

You will now be in a residential area – Fairlington – with red brick townhomes.

Follow 31st Street through another stop sign (Long & Foster building will be on your left)

Proceed up a small hill.

On your left will be two, two-story brick office buildings.

You may park anywhere in the parking lot

My office is in the first building, which has a large sign reading **Huntington Learning Center.**

My office is on the second floor to the left as you come up the stairs.

If you reach a dead end, you've past my office

From 395 via King Street

Take King Street Exit (Ext 5)

At the fork, go West

Almost after you exit, take a right onto 30th Street. (There is no stop sign here, so watch closely. A Fairlington brick sign will mark the entrance.)

At the roundabout take a right on Columbus Street. Follow Columbus for a short distance. You will be in a residential area with brick town homes.

Columbus dead ends into 31st, take a left.

In less than 100 yards, turn right into the parking lot.

You may park anywhere.

My office is in the first building, which has a large sign reading **Huntington Learning Center.**

My office is one the second floor to the left as you come up the stairs.

Metro from D.C.

Take the Yellow or Blue Line to the Pentagon metro stop

At Pentagon, take the 22A. Tell the bus driver you need to get off at the corner of 31st and Abingdon, right near the fire station on the bridge.

After getting off the bus, walk a short distance on Abingdon until you reach the corner of Abingdon and 31st Street.

Turn right on 31st Steet. My office is approximately 250 yards away.

Walk past the Long & Foster building on your left.

Walk up a short hill and my office is in the office park on your left.

It is located on the second floor of the building marked "Huntington Learning Center"
